14/03868/HOU – Two storey infill extension between the existing house and garage and reorientation of the garage roof at Horkinstone Barn, Denholme Road. The Parish Council raises no objections.

14/03779/FUL – Change of use from former public convenience to garden at land adjacent to 14 Lower Town. The Parish Council raised no objections although members regret the loss of the public conveniences in the village and were still disappointed that they were unable, due to circumstances beyond their control, to pursue the Parish Council's approved planning application 05/01344/FUL to convert the public conveniences into a superloo and contact point.

14/03502/HOU – Demolition of existing single storey extension and construction of two storey extension and single storey side extension at Cobling Barn, Sawood Lane. The Parish Council raised no objections but concern was raised regarding proportionality.
